

Q2 2018 BOT Approved Proposals and Consultancies

Proposals

1. Communications Research and Development of a 3 1/2-Year Communication Strategy for Sierra Madre, Palawan, and Samar and Leyte by DraftFCB

The project aims to develop an evidence-based 3.5-year communications strategy for the Foundation's three focal landscapes (Sierra Madre, Palawan, and Samar and Leyte).

2. Enhancing Biodiversity through Social Enterprise by the Palawan Center for Appropriate Rural Technology

The project is a collaboration among local funding institutions (Forest Foundation Philippines, Foundation for the Philippine Environment, Foundation for Sustainable Society, and Peace and Equity Foundation) to build on the gains of the Startreks 1 and 2 projects. The Foundation's assistance will be allocated to the preservation of KBA 60 and 62, abaca social enterprise development and capacity building of the PO.

3. Enhancing the Knowledge Platform for Palawan's Wild Flora and Fauna Palawan by the State University - Center for Strategic Policy and Governance and Palawan Council for Sustainable Development

The project aims to enhance knowledge about Palawan's wildlife by gathering data and developing a tool for data management.

4. Establishment of Local Conservation Areas in 3 Barangays of Puerto Princesa City by the Palawan Conservation Corps

The project aims to establish Local Conservation Areas (LCAs) in three (3) barangays in Puerto Princesa City as a strategy to protect and enhance biodiversity, as well as alleviate anthropogenic pressures in the corridors and buffer zone of the Puerto Princesa Subterranean River National Park (PPSRNP).

5. Establishment of a Long Term Ecological Monitoring Plot in Angat Watershed by the University of Santo Tomas - Research Center for Natural and Applied Sciences

In partnership with NPC, the project intends to establish a long term ecological research (LTER) site in Angat Watershed Reservation. The LTER site is envisioned to provide the faculty and students of UST (and other schools/universities in Bulacan and Metro Manila) with the appropriate resources to support their overall objectives and the pursuit of long term ecological research.

6. Strengthening Environmental Protection through a Strategic Environmental Defense Program by the Environmental Legal Assistance Center

The project aims to implement an environmental defense program to enhance forest and environmental governance, contribute to forest and environmental policy reform, and strengthen the implementation of Palawan's conservation and natural resource framework.

7. Strengthening the Indigenous Community of Egongot Tribe in Dimasalang for Forest Protection and Conservation by the Dimasalang Egongot Tribe Farmers and Weavers Association

The project aims to strengthen the capacities and capabilities of the Dimasalang Engongot Tribe to manage their ancestral domain and forest resources.

8. Strengthening the Protection of Busuanga's Natural Forests (Beach and Mangrove) through Community Partnership by C3 Philippines

The project intends to protect and enhance the mangrove and beach forest ecosystems in Busuanga Island.

B. Consultancy

1. Capacity Building on International Multilateral Processes on Climate Change and Biodiversity by Parabukas Pte. Ltd.

The consultancy aims to help build the capacity of Philippine government officials to actively engage in multilateral processes related to climate change and biodiversity. Capacity-building activities will focus on UNFCCC and CBD negotiations, as well as their linkages to domestic plans and programs.
